

## Terms of Sales

### Cottage rental:

- 1) The rental becomes effective only after the agreement of the campsite and upon receipt of the deposit requested at the time of booking (30% of the rental price).
- 2) Once the reservation has been confirmed by the campsite, the tenant agrees to pay the full amount of his stay at least 30 days before the start of his stay. In case of non-payment in time, the deposit will remain acquired at the campsite and the reservation will be considered canceled.
- 3) If there is availability and a cottage is booked less than 30 days before the stay, the entire stay must be paid upon booking.
- 4) At the arrival of the tenant at the campsite, a deposit of 200 € is required. This is to cover any deterioration of the equipment or the accommodation itself. In the event of a messy rental, the cleaning fee (60 €) will be deducted from the deposit.
- 5) Except for special mentions (special offers, extended weekends, etc.), on the day of arrival, the chalets are available from 3 pm and must be occupied at the latest at 8 pm. Without appeal, letter or email from the client stating that he had to postpone his arrival, the cottage becomes available the day after the date of arrival at noon. After this period, the booking will be canceled and the amount collected will not be refunded.
- 6) In the event of eviction or if the tenant leaves before the fixed date of departure, he will not be able to claim any refund or have.
- 7) The tenant will have to leave his accommodation, on the day of departure scheduled between 8 am and 10 am, except when particular mentions or agreement of the direction (special offers, extended weekend, etc.).
- 8) The tenant will have to respect his house, namely to return it in the state where he found it. Even if the tenant has taken the cleaning package, he will have to do his dishes and put it away where he found it. As a reminder, the cleaning package includes the broom, the mop and the cleaning of the bathroom. If the dishes are not made and stored, the sum of 60 € will be deducted from the deposit.
- 9) The tenant agrees to respect the rules of the campsite Les Lavandes in Darbres

Campsite :

- 1) The rental becomes effective only after the agreement of the campsite and upon receipt of the deposit requested at the time of booking (30% of the price of the stay).
- 2) Once the reservation has been confirmed by the campsite, the tenant agrees to pay the full amount of his stay at least 30 days before the start of his stay. In case of non-payment in time, the deposit will remain acquired at the campsite and the reservation will be considered canceled.
- 3) If there is availability and a location is reserved less than 30 days before the stay, the entire stay must be paid on booking.
- 4) Except for special mentions (special offers, extended weekends, etc.), on the day of arrival, the pitches are available from 12 noon and must be occupied by 9 pm at the latest. Without appeal, letter or email from the client stating that he had to postpone his arrival, the location becomes available the day after the date of arrival at noon. After this period, the booking will be canceled and the amount collected will not be refunded.
- 5) In case of eviction or if the camper leaves before the fixed date of departure, he can not claim any refund or have.
- 6) The camper will have to leave its site, the day of the departure envisaged between 8:00 and 11:00 of the morning, except during particular mentions or agreement of the direction (special offers, extended weekend, etc.).
- 7) The camper must respect his pitch, namely to return it to the state where he found it.
- 8) The camper agrees to respect the rules of the campsite Les Lavandes in Darbres
