## Rules of the campsite Les Lavandes à Darbres

- Conditions of admissions and stay: To be allowed to enter, to settle, or to stay on a campground, it must be authorized by the manager or his representative. The latter has the obligation to ensure the good behavior and order of the campsite and compliance with the application of these rules. Staying on the campsite implies acceptance of the provisions of these rules and the commitment to comply with them. No one can choose to live there.
- Police formalities: Minors can not stay on the ground without being accompanied by their parents. Pursuant to article R611-35 of the code of entry and residence of foreigners and the right of asylum, the manager is required to have the client complete and sign the foreign nationality, upon arrival, an individual record from police. It must mention in particular: name and surname, date and place of birth, nationality, usual place of residence. Children under the age of 15 may appear on a parent's card.
- 3) Camping: The tent or caravan and related equipment must be installed at the location indicated and in accordance with the directions given by the reception. Rental: On arrival we will give you the keys, a deposit of 200 € lump sum will be required by Visa, Master Card or check. We will therefore ask you to take care to keep the rental in good condition: A lump sum of 60 € is required if the rent is not made in perfect state of cleanliness at the time of the inventory of fixtures. Any damaged or broken object will have to be refunded by the tenant.
- 4) Pets: is allowed a dog or a pet per rental. Animals considered dangerous and category 1 and 2 dogs are not allowed. Animals must be vaccinated and kept on a leash. At no time can an animal be left without its owner in the campsite. Thank you to respect the cleanliness of the domain and to collect the excrements of your animal. Any damage will be retained on the deposit. The pet owners are civilly responsible for their animals and the management declines all responsibilities in case of problems...
- 5) Reception: Open from 08:00 to 18:00. You will find at the reception all the information on the services of the campground, the information on the possibilities of refueling, the sports facilities, the tourist wealth of the surroundings and various addresses which can be useful.
- 6) Display: These rules of procedure are posted at the entrance of the campground. It is given to each client who requests it. For classified campsites, the classification category with the mention of tourism or recreation and the number of tourist or recreational sites are

- displayed. The prices of the different services are communicated to customers and can be consulted at the reception
- 7) Conditions of departure: Customers intending to leave before the opening hours of the reception must pay the day before the payment of their stay. ARRIVAL / DEPARTURE: without letter or email from the client stating that he had to postpone his arrival, the location becomes available the day after the arrival date mentioned on the booking contract, at noon (past this time, the reservation will be void and the amount cashed will not be refunded). If you are expelled or leave before the date set for your departure, you can not claim any refund or have. Pitches: arrival time from 12am to 7pm and departure time from 4pm to 7pm and departure time from 4pm to 7pm and departure time from 8am to 10am
- 8) Noise and silence: Guests are urged to avoid any noises and chatter that might disturb their neighbors. The sound devices must be adjusted accordingly. Closures of the doors and chests should be as discreet as possible. Noisy activities that may interfere with other campers are prohibited. The manager ensures the tranquility of its customers by setting schedules during which the silence must be total between midnight and 7am.
- 9) Visitors: After having been authorized by the reception, the visitors can be admitted in the camp-site under the responsibility of the campers who receive them. The services and facilities of the campgrounds are accessible to visitors. However, the use of this equipment may be subject to a fee which must be posted at the entrance of the campground and at the reception desk. Visitors do not have access to the pool. All visitors must leave the campsite before midnight. Conditions: Visitors' cars are forbidden in the field. They must be parked in the car park located at the entrance of the campsite. Each visitor must deposit and collect his ID at the reception of the campsite.
- 10) Vehicle Traffic and Parking: Within the campground, vehicles must drive at a limited speed (10km / h). Traffic is allowed between 07:00 and 23:00. Only vehicles belonging to campers staying in the camp may be driven in the camp. Parking must not obstruct traffic or prevent new arrivals. One vehicle per location. The additional vehicle is parked in the car park at the entrance of the campsite and costs € 3.
- 11) Dress and appearance of facilities: Everyone is required to refrain from any action that could affect the cleanliness, hygiene and appearance of the campsite and its facilities, including health. For your comfort, the sanitary facilities are regularly cleaned. The cleanliness of these places must be respected by the users. It is forbidden to throw sewage on the ground or in the gutters. Customers must empty their waste water in

the facilities provided for this purpose. You are requested to respect and protect the trees and plants of the campsite; do not pour dishwater into the plants; do not plant nails in trees; do not hang clothes between the trees; do not put waste in the toilet. When leaving, please leave your site clean and do not leave garbage bags, papers or other waste. Garbage, waste of any kind, papers, must be deposited in the containers provided for this purpose, on the selective sorting area at the entrance of the campsite. Washing is strictly forbidden outside the bins provided for this purpose.

- 12) At the entrance to the campsite there is the selective sorting air. Waste must be sorted and placed in the correct containers (signs are installed at the entrance to the room and indicate which waste goes into which container). The waste, whose place is in the green containers, must imperatively be placed in garbage bags and the latter must be closed before being placed in the green container.
- 13) Safety: a) Fire: Open fires (wood, coal, etc ...) are strictly forbidden. Only gas barbecues are allowed. Stoves must be kept in perfect working order and must not be used in a tent or near a car. Stoves with alcohol or gas are also prohibited. In case of fire notify the management immediately. Contact information for doctors, firefighters, etc. are available at the reception.
  - b) Theft: The management is responsible for the items deposited at the reception and has a general obligation to monitor the campsite. The camper keeps the responsibility of his own installation and must signal to the reception the presence of any suspect person. Users of the campsite are invited to take the usual precautions for the safeguarding of their equipment, object ... The management declines any responsibility in case of theft.
- 14) Games: No violent or embarrassing games can be organized. The management declines all responsibility in the event of an accident. The games at your disposal are fragile, you must ensure that your children do not degrade it under penalty of penalty and royalty. Ball games (football, etc.) will take place on the appropriate grounds and not around or inside the buildings.
- 15) The use of drones and other flying objects is totally prohibited throughout the campsite.
- 16) Dead garage: It can not be left unoccupied equipment on the ground, only after agreement of the direction and only in the indicated location. Management is not responsible for this material in the absence of the owner. The rate applicable for the "dead garage" is that of the 2 persons pitches corresponding to the dates of the rates posted at the entrance of the campsite.

- 17) Swimming pool: You must leave your shoes at the entrance, go through the footbath and take a shower. Children under 12 must be accompanied by their parents and under constant surveillance. Beyond this age and up to 16 years old, they must know how to swim and under the responsibility of a person of full age. In no case their elders nor our staff are considered responsible. We do not accept liability for accidents or It is forbidden to wear t-shirts, undershirts or any other item of clothing, excluding the swimsuit. It is forbidden to book sunbathing with towels or other means if you do not stay at the pool. We reserve the right to remove any napkins without the presence of a person after a given time. . It is forbidden to smoke, eat and drink in the pool. The use of the pool is allowed only during dedicated hours.
- 18) Violation of the rules of procedure: In the event that a resident disturbs the stay of the other users or who does not respect the provisions of the present rules of procedure, the manager or his representative will be able, orally or in writing if it deems it necessary, to put in remains the latter to stop the troubles. Any breach of these rules will not be tolerated and will result in an immediate expulsion without any possibility of reimbursement, and especially in case of disruptive attitude contrary to the calm and serenity of the reception or in case of violent behavior, offensive words, racist threatening against other customers, camping staff or its partners or suppliers. In the event of a criminal offense, the manager may appeal the police.
- 19) Bar / Catering / Supermarket: It is forbidden to sell alcohol to minors under 18 years old. It is forbidden to come to the bar with your own consumption. It is forbidden to hinder and hamper the service of the personnel.
- 20) Animations: We are not responsible for your children. Parents must stay on the campsite. The management declines all responsibility in the event of an accident occurring during the various activities and activities.
